The program utilizes three phases to eliminate student loan debt for our missionary partners:

1) Qualification - A candidate applies online and begins the process with our program director, including phone interviews, a credit check, and reference checks.

2) Selection - The candidate submits a ministry overview video and is interviewed by a volunteer selection committee before a final decision is made.
